SARILIA SOLID WASTE COLLECTION AND DISPOSAL BYLAW

A BYLAW TO AUTHORIZE A SPECIAL TAX FOR SOLID WASTE COLLECTION AND DISPOSAL IN THE SARILIA ESTATES SUBDIVISION.

The Council of the Rural Municipality of Laird No. 404, in the Province of Saskatchewan enacts as follows:

- 1. A Special Tax be levied against all benefiting lands, as per Appendix A, for the purpose or service of solid waste collection and disposal to be completed within the current year.
- 2. The collection and disposal of solid waste is hereby authorized on each occupied residential property with an improvement located in the subdivision of Sarilia Estates.
- 3. The estimated cost of the solid waste collection and disposal is five thousand six hundred forty dollars (\$5,405.00).
- 4. The tax rate is \$235.00 per parcel of land to be levied against all assessed owners of land according to their respective parcel of land.
- 5. Any person who considers that an error or omission was made in the application or calculation of the special tax on his or her property may notify the municipality in writing by September 30, of current year, requesting the council to review the application or calculation of the tax rate regarding the property in question.
- 6. The Administrator will notify the persons, who have requested a review, of the time and date the council will meet to hear and review the requests.
- 7. The taxes that are levied will be added to the tax roll as a special assessment against the property, when they become due and payable, and are recoverable in the same manner as other taxes.
