RURAL MUNICIPALITY OF LAIRD NO. 404

**A BYLAW OF THE RURAL MUNICIPALITY OF LAIRD NO. 404 TO AMEND BYLAW
NO. 6-2008 KNOWN AS THE ZONING BYLAW**

The Council of the Rural Municipality of Laird No. 404 in open meeting hereby enacts as follows:

1. The **Zoning Map(s)** referred to in **SECTION 5**, and identified as being "Appendix A" to the Zoning Bylaw, is amended by rezoning from **Agricultural District (AG)** to **Agricultural Residential District (AR)**, all of the proposed Parcel A lying within LSD 8-24-41-07-W3M Ext. 19, as shown within the bold-dashed outline on the plan of proposed subdivision (revision 1, dated January 28, 2026) prepared by Daniel L. Codling, SLS, of Meridian Surveys Ltd., attached to and forming part of this bylaw as Schedule "A".

This bylaw shall come into force on the date of final approval by the Minister of Government Relations.



R.M. OF LAIRD No. 404, SK


