- **074.Apr.23 BOLDT:** That Council has raised the following matters and request that CPB broaden its referrals and consider this information:
 - We undertook a review of historic aerial imagery. This is from Google Earth dated May 28, 2012. As shown, intermittent surface ponding poses significant development limitations (specifically in proposed Parcel D). We note the application not being referred to WSA. As the proposed three new parcels are undeveloped, the RM would prefer that the CPB review include a determination of MBE rather than the RM having to make this request of individual owners once the parcels may be created and sold at a later date. Given the localized ponding and the outcome of any hydrological review by WSA or third-party consultant, the RM may request some level of drainage planning.



A member of Council indicated that this portion of Twp Rd 402 is under some sort of control or jurisdiction of MHI (SaskInteractive Map would support this premise). Should that be the case, we believe its referral/comments to be relevant given the potential for 3 new approaches and note that it wasn't provided a subdivision referral. The RM would specifically want to know if any service road dedication is required by MHI as it may impact the need and content of a potential servicing agreement. Beyond any need for potential roadway upgrades or development of service road, at this time Council does not see a need for a servicing agreement for any other matter.

It is noted that the last 3 multi-parcel subdivisions that have occurred in the area have
required the provision by the applicant of a hydrogeological study or assessment to
determine suitable options of private on-site sewage disposal. The RM would want to know
ASAP if this is going to be the case again. Further, the RM would be interested to know
whether a Type II mound or similar system should be located such to avoid topographic
lows and whether this consideration is made by SHA at the time of sewage permit review.

The RM has recently set its MR CIL rate at \$10k/ac for residential. This would result in a CIL payment of \$17,600. Final amount however, will be confirmed upon full consideration by Council of the proposal.

Council is aware that rezoning of the subject land is required and that the CR2 District is the best candidate based on site use and site regulations. The land is already designated for multi-parcel country residential on the OCP FLU Map. Note however, that the RM would also be pursuing textual OCP and ZB amendments to introduce more flexibility and scaled evaluation of CDR and sewage requirements for multi-parcel country residential development along with a number of other miscellaneous items. Until such time that a better picture of suitability is determined considering the factors above and others, the RM believes that pursuing any necessary bylaw amendment(s) is premature. Further, no application or fees for amendment have been received from the subdivision applicant.
