#### **MUNICIPAL REVENUE SHARING 2023 DECLARATION**

- **204.Nov.23 GRUNAU:** That the Council of the RM of Laird No. 404 confirms the municipality meets the following eligibility requirements to receive the Municipal Revenue Sharing Grant which includes the following:
  - 1. Submission of the 2023 Audited Financial Statement to the Ministry of Government Relations (to be submitted after audit date of February 2024 by Auditor);
  - 2. The Municipality does not run a Municipal Waterworks Systems;
  - 3. In Good Standing with respect to the reporting and remittance of Education Property Taxes;
  - 4. Adoption of a Council Procedures Bylaw;
  - 5. Adoption of an Employee Code of Conduct; and
  - 6. All members of council have filed and annually updated their Public Disclosure Statements, as required; and

That we understand if any requirements are not met, our Municipal Revenue Sharing Grant may be withheld until all requirements are met (use only if not all requirements are met); and

That we authorize the Administrator to sign the Declaration of Eligibility and submit it to the Ministry of Government Relations. **CARRIED.**

## SAWATSKY SUBDIVISION

208.Nov.23 BOLDT: That Council not support the proposed subdivision known as Community Planning branch file #SUBD-002159-2023 for reason of non-compliance with the RM's Zoning Bylaw (ZB). The subject land is located in the Agricultural District (AG) with the proposed use being for general agriculture. Sch A 1.5 of the ZB prescribes a minimum site size for the proposed use of 64.80 ha (or equivalent as described in 1.6 1.). Further, there is no policy in the RM's Official Community Plan guiding agriculture subdivision; there is specific policy to guide subdivision for other uses with limited site sizes. The proposed parcel and the residual portion of the source parcel would not achieve the minimum site area. Council discussed the potential of undertaking any necessary amendments to accommodate the proposal but is unwilling to amend its ZB to accommodate the proposal, nor is there any other Zoning District within the ZB which would readily accommodate the proposed use(s) of the subdivided parcels.
