CLUBROOT AND WEED INSPECTOR APPOINTMENTS

If your RM has not already done so, please consider appointing the Plant Health Officers as Pest Control Officers for Clubroot in 2022. This appointment allows the PHOs to complete the provincial clubroot survey and allows the PHOs to work with producers who have clubroot to create clubroot management agreements. Please send the signed appointment letter to the Ministry of Agriculture at Room 125, 3085 Albert Street, Regina, SK S4S 0B1, or email the letter to crops@gov.sk.ca.

Clubroot bylaws are a tool for RMs in managing clubroot in Saskatchewan. If your RM has yet to put a clubroot bylaw in place, please think about adopting the clubroot bylaw. If your RM has recently adopted a clubroot bylaw, please send a copy to your Plant Health Officer, so your RM can be added to the RMs with Clubroot Bylaws Map. If you have any questions regarding clubroot bylaws or policies, please reach out to your PHO.

Weed Inspector appointments should be made in January each year. Weed Inspector Acknowledgement letters are required by July 2nd to participate in the Invasive Plant Control Program (IPCP). Even if your RM does not currently plan to claim to the IPCP, the RM must have an appointed Weed Inspector acknowledged by the Ministry of Agriculture if any ratepayer within the RM wants to apply to the IPCP later in the season.

WEEDS TO WATCH FOR **COMMON TANSY**

One invasive weed that can be identified during the winter and spring is common tansy. Tansy is a noxious weed under the Saskatchewan Weed Control Act. Common tansy is a perennial weed with a tap root, fern-like leaves, and yellowbutton flowers. Common tansy is a tall weed that is found along roadsides and in forage areas. A unique quality about this weed is that its growth remains standing in winter. The plant, with its shriveled leaves and seed heads can be seen standing above the snow. This is a great identification tool during the winter months to determine if common tansy is present in your RM.
